# Alumni Dependent

\$400 per year to children, grandchildren, siblings, and spouses of alumni.

#### **Baptist Student**

\$400 per year to students who are recommended by a pastor of a Southern Baptist Church.

# **CRV** Dependent

\$600 per year for dependents and spouses of pastors and other full-time ministerial employees of Southern Baptist churches, associations, or agencies.

#### **Dual Credit**

\$1,000 for the first term of enrollment for students who have participated in William Carey's Dual Credit program or Step Ahead program while in high school. (Not applicable for transfer students)

#### **Scout Leadership**
